Alexander Devine is the extraordinary and brave boy who inspired our children's hospice service. He was just four years old when he was diagnosed with a brain tumour and there is simply nothing in this world that can prepare a family for such devastating news. He endured four and a half years of treatments and sadly, aged eight, he died.

Inspired by their son, Fiona and John Devine set up the charity Alexander Devine Children's Hospice Service. This is the beautiful legacy Alexander has left.



Writing your Will

Your Will is one of the most important documents you will write. It's the only way to be sure your family will be looked after in the way you intend.

Writing or updating your Will can be very quick and easy. But here are some points to consider before starting the process.

Think about your assets

List the assets you own, their worth and whether you share ownership with someone. You should think about any debts you might have too.

Consider who you want to pass your estate on to and what value each individual should inherit. You should also consider any dependents and who would be responsible for them should you pass away.

Appoint your Executors

Your Executors are the people named in your Will who will ensure your wishes are honoured after you die. They can be anyone you trust, or even organisations, and you can have more than one executor if you prefer.

If you choose a loved one to be your Executor, it's a good idea to discuss this before appointing them to make sure they're happy.

Leaving a gift in your Will

Whilst there is no obligation, after taking care of your loved ones, we'd be grateful if you would consider leaving a gift to Alexander Devine in your Will.

There are two main types of gift you might choose to leave:

Residuary gift: A percentage share of your estate. This type of gift is particularly powerful as it holds its value even as the cost of living rises.

Pecuniary gift: A fixed and specific sum of money. Inflation means this gift will lose value over time, but we'd still be very grateful for any sum you leave.


Creating your legal document



The difference your support will make – Riley's story.

Riley was born with a rare chromosomal genetic condition that shapes every aspect of his life. He has extremely limited mobility, relies on a wheelchair, is tube fed, and is non-verbal. His needs are complex and constant, but to his mum, Shailza, he is simply Riley.

"I don't see Riley as his disability. I just see my child. This is the only life we've ever known."

Since 2017, Riley and his younger brother Stanley accessed support from the hospice through a self-referral. What began as a step into the unknown soon became something far more meaningful, a place of care, comfort and community.

Today, Riley attends the hospice regularly. He enjoys day care, hydrotherapy, music therapy, and one of his absolute favourites, the Family Fun Days.

In 2022, Riley's brother Stanley died from the same condition. Through it all, the hospice has continued to support the family.

"The remembrance events are not just a time to stop and remember Stanley. They're an opportunity to be with other families and remember I'm not alone. Together, we will always carry them in our hearts."

"For me, the hospice brings me peace of mind and a small opportunity to have a break. It's an environment where I know I can trust the staff and have a moment to switch off."

Help your estate and your local children's hospice

Madeline Harris, Solicitor at NE Family Law in Windsor, explains some of the benefits for your estate when you leave a gift to a charity in your Will.

"Gifting to charity in your Will not only benefits the charity but also offers tax advantages for your estate. Charitable donations are exempt from inheritance tax, which means the value of your estate can be reduced by the amount of your charitable gift, potentially lowering the tax burden on your estate. Additionally, in England, if you leave at least 10% of your net estate to charity, the inheritance tax rate on the remainder of your estate can be reduced from 40% to 36%.

This means that by supporting a charity in your Will, you can make a positive impact on the community and achieve more favourable tax planning for your estate.

It's a win-win situation that ensures your legacy supports both your loved ones and the causes you hold dear."

Frequently asked questions

What information do I need to leave a gift in my Will?

All you need to leave a gift in your Will to Alexander Devine Children's Hospice Service is our charity name, address and registered charity number detailed below.

I've already got a Will, can I still leave a gift to Alexander Devine?

Yes, simply fill out a Codicil form. You'll need our address and charity number (above). Speak to your solicitor or Will provider who can advise you further.

Are there tax benefits of leaving a charitable gift in my Will?

Most gifts left to charity are exempt from inheritance tax and you could reduce the amount of tax paid by your beneficiaries by leaving us a gift in your Will. Find out more at www.gov.uk/inheritance-tax or speak to your solicitor.

What if I want to change my Will later?

It's a good idea to regularly update your Will so that it doesn't become out of date. You can either write a new Will or amend your existing one using a Codicil form. Speak to your solicitor for further advice.
